In 2006, Massachusetts enacted a sweeping health insurance law that mirrors the legislation currently before Congress. In a new study, Cato scholars Aaron Yelowitz and Michael F. The bottom line: "The costs may be far greater than legislators and voters believe, while the benefits may be smaller than the conventional wisdom about Massachusetts suggests."
