Tomoya Obokata is a Japanese scholar who joined the School in 2012 as Professor of International Law and Human Rights. Previously he taught at Queen's University Belfast (2006-2012) and University of Dundee (2004-2006). He holds BA in International Relations (University of Southern California), MA in Theory and Practice of Human Rights (University of Essex), LLM in International Criminal Law (University of Sussex) and PhD in Law (University of Nottingham). Prior to commencing his PhD degree, Professor Obokata worked for the United Nations High Commissioner for Refugees Regional Office of Japan and the Republic of Korea (1999-2000).

Professor Obokata's expertise lies in transnational organised crime generally and trafficking of human beings in particular. He has a number of publications on these topics and currently serves as the Adviser to the Northern Ireland Assembly All Party Group on Human Trafficking. Previously he advised the bodies including the UK Parliamentary Joint Committee on Human Rights, the International Organisation for Migration and the European Union.

Professor Obokata is currently leading a major research project entitled "North-South Irish Responses to Transnational Organised Crime," funded by the Arts and Humanities Research Council (£195,000), as the Principal Investigator. In this project, the research team is examining the extent to which Northern Ireland and the Republic of Ireland has been successful in implementing action against major crimes such as drug and human trafficking as well as cigarettes/fuel smuggling, with particular reference to cross-border cooperation.
