# invitation of the second regional forum on legal cooperation

May 25, 2007 Dear Sir or Madam,

On behalf of China Law Society, I sincerely invite you an d a delegation from your organization to attend the secon d Regional Forum on Legal Cooperation to be held from Aug ust 1 to 5, 2007 in Xi' an, Shaanxi Province, China. This For um is expected to enjoy participation of about 100 delegate s including judicial officials, lawyers, law experts and schola rs and entrepreneurs from Azerbaijan, Belarus, Bulgaria, China, Czech, Hungary, India, Kyrgyz, Mongolia, Pakistan, Polan d, Russia, Tajikistan and Uzbekistan, following the spirit of cooperation, development and Win-Win, to discuss legal is sues of common interest in this area.

In August, 2006, more than 300 delegates from Azerbaija n, Belarus, China, India, Kyrgyz, Mongolia, Pakistan, Russi a, Tajikistan and Uzbekistan participated in the first Region al Forum on Legal Cooperation in Urumqi, Xinjiang Autonom ous Region, China. During the Forum, focusing on "Strength en Legal Exchange and Promote Regional Economic Cooperat ion", the delegates deeply explored and reached broad con sensus on the economic and social opportunities and challen ges of this region and they unanimously agreed that it was of great significance to strengthen the dialogue, exchange and cooperation among the legal circles of the countries in this region so as to promote the mutual understanding an

d trust among the countries, to ensure the smooth flow of tr ading and investment and to promote the comprehensive st ability, prosperity and development of this region. On the cl osing ceremony of the first Forum, 42 organizations from th e above countries became the founding member of the Foru m and approved and signed the Urumqi Declaration, showin g that we legal circles of this region would try our best to en hance the peace, stability, development, prosperity and har mony of this region.

In order to continuously further the friendship and unders tanding among the legal circles of this region, to consolidat e the achievements of the first Forum and to fulfill the Urum qi Declaration, China Law Society would like to hold the sec ond Regional Forum on Legal Cooperation from August 1 t o 5, 2007, in Xi' an, Shaanxi Province, China.

The theme of the second Forum is "Strengthen Legal Co operation and Promote Harmonious Development of the Euro pean-Asian Region".

The proposed topics include:

- 1 The Role of Law in the Process of Promoting Harmonio us Development of this Region
  - 2 The Legal Protection of Foreigners of the Host Country
  - 3 Comparative Study of Investment Laws

For other topics, it is open to your suggestions.

In addition to the workshops on above topics, there ar e various programs available to all participants, such as Ope ning and Closing Ceremonies, Seminars, visiting joint ventur es, sightseeing in Xi' an and visiting the world famous Emp eror Qin's Terro-cotta Warriors.

The second Forum will still be sponsored by China Law S

ociety and organized by Law Society of Shaanxi Province an d China Legal Exchange Center, and widely supported by th e China central government, local government and related in stitutions and authorities.

The second Forum is scheduled for five days from Augus t 1 to 5, 2007 (Registration is on August 1, 2007). The regis tration fee is US\$100 for each delegate, which includes the e picking-up and seeing-off services at the airport, conference e documents, working meals, welcome and farewell banquet s, visiting the Emperor Qin's Terro-cotta Warriors and trans portation from and to the conference venue during the Foru m. However, the accommodation shall be undertaken by del egates themselves. As a Distinguished Guest, such as Presi dent of nation-wide legal organization, President of Suprem e Court, Attorney-General or Chief Prosecutor, Minister of Justice, the registration fee as well as the accommodation i n Xi' an will be borne by China Law Society.

We are trying our best to make the second Forum an aca demic platform for experts and scholars to exchange idea s, a ground for entrepreneurs to catch commercial opportunit ies and a bridge for participants to make friends.

We are looking forward to welcoming you in Xi' an, Shaa nxi.
