# Biography

Peter Sells' research is primarily concerned with comparative aspects of grammar, from a theoretical standpoint. His expertise is primarily in syntax, as well as its interfaces to morphology and semantics, with a particular focus on Japanese and Korean linguistics.

Having grown up in Sheffield, he studied for his BA at the University of Liverpool, and then received his PhD in Linguistics from the University of Massachusetts, Amherst. He spent many years at Stanford University in California before returning to the UK in 2007.

### Research

#### Overview

My primary research interest is in the nature of grammatical theory, in particular what the components of morphology, syntax and semantics look like, and how they relate to each other. In the past have worked in a variety of theoretical frameworks on a variety of languages, primarily Korean, Japanese, Chinese, Philippine languages, and Swedish.

My current work on Korean involves aspects of syntax and semantics, in joint work with <u>Shin-Sook Kim</u>, primarily involving negation, scope, and licensing. We are also working on Korean noun-modifying clauses as part of a project funded through Stanford University. In addition, I work on aspects of Korean and English syntax with <u>Jong-Bok Kim</u>.

My current work on Japanese is largely related to a study of verb semantics and argument realisation in Premodern Japanese as part of an AHRC-funded project on this topic, based in Oxford (2008-2013). This is a study of the syntax of Old Japanese (c. 8th century). One outcome of this project is the Oxford Corpus of Old Japanese, which will be developed over the coming years, and has recently received recognition from the British Academy as an Academy Research Project. The partners in this project are Oxford, York, and the National Institute for Japanese Language and Linguistics.

A secondary interest of mine is the use of linguistic approaches to an analysis of the language and design of advertising. I have some earlier work online. I hope to offer classes on this topic in the future.
