## 各有关单位:

胡锦涛总书记在今年人口资源环境工作座谈会上指出,要大力宣传循环经济理念,加快制定循环经济促进法,加强循环经济试点工作,全方位、多层次推广适应建立资源节约型、环境友好型社会要求的生产生活方式。近期,国务院确定了我国发展循环经济和建设节约型社会的总体战略,发布了《关于做好建设节约型社会近期工作的通知》和《关于加快发展循环经济的若干意见》,国家环保总局解振华局长还主编出版了《领导干部循环经济知识读本》。这些都为我国发展循环经济指明了方向和实现途径。

Announcement of the First China Eco-Fortune Forum & Building R esources-saving and Environment-Friendly Society Summit

President Hu Jintao emphasized at the Meeting for Population, Resources and En vironment that it is fundamental to implement the theory of circular economy, to sp eed up the legislation of the Law on the Promotion of Circular Economy, to enhance e the circular economy demonstration projects, and to promote the corresponding product and lifestyles in an all round for building resources-saving and environmen t-friendly society. Recently, the State Council set the integrated strategy for develo ping circular economy and building resource-saving in China, and strives to build energy conservation society. Meanwhile, Minister Xie Zhenhua of SEPA compiled a Reading on a Recycling Economy for Local Officials. All of these show the direct ion for CN circular economy development, and implementation approaches are b ecoming clearer.

In order to extending the Eco-Fortune idea, The First China Eco-Fortune Forum & Building Resources-saving and Environment-Friendly Society Summit will be held in Beijing from Dec.16<sup>th</sup> to Dec. 18<sup>th</sup>, 2005, which is under the supervision of Chin a Association for Science and Technology and SEPA, organized by the CN Socie ty for Environment Sciences, and supported by Eco-Fortune magazine. The Forum will provide an open, steady and solid communication platform for the government at different level, related administrative departments, enterprisers, experts focusing on green economy, industry management and research, and people interested in sustainable development in China and the world.
