P12 The State Council held a National Emergency Management Conference

The State Council held a national emergency management conference from July 22 to 23, which asked all regions and departments, under the leadership of the Party Central Committee and the State Council, to set up an emergency management system which based on categorized management, hierarchical-responsibility and horizontal and vertical combined concentrating on local management, and form a emergency mechanism featuring unified command, complete functions, quick response and efficient operation. Governments at all levels were asked to put the emergency management at a more important position, and make more public resources, humans, financial and materials into social management and public services.

P12 Occupational Health Supervision in Coal Mine must be strengthened

A national occupational health symposium in coal mine was held in Beijing on August 3. The conference which convened by the State Administration of Coal Mine Safety, summarize and exchanged the occupational health supervision status in the coal mine enterprises,, and prepared for better occupational health supervisions especially on-the-spot supervision and for better prevention and control of occupational hazard worksite in the coalmine and for ensuring coal miners' safety and health.

P12 The 93rd International Labor Conference Held in Geneva

From May 31 to June 18, 2005, the 93rd ILO conference and the occupational safety and health committee conference were held in Geneva.

The representatives from the State Administration of Work Safety (government), All-China Federation of Trade Unions (employees) and China Enterprise Federation (employer) attend the conference.

P12 Chinese Mines Will Farewell with the Dual System

At present, China's coal enterprises order is very chaotic, the national average coalmine resource recovery rate is between 30% and 35% and this data in smaller shafts is only 10% to 15%, said an official. of Finance Ministry The mining industry right acquired without remuneration or at low price was one of the important reasons.. From now on the state will take the coalmines as key to push the remunerative use of mining industry right, unify the present dual system of remunerative and non-remunerative mining industry right use into a system of remunerative obtainment. The official also said that the low cost of mining market access caused carelessness for the resources using and about production safety.

P13 Speed of Virulent Chemicals Transporting Vehicles Limited

On July 22, Methods of Management for Virulent Chemicals Purchase and Highway Transport License (Order No. 77) issued by the Ministry of Public Security (Methods for short), which would started to implement on August 1. The Methods clearly defined the deadline of certification and stipulating that highway transporters of virulent chemicals were required to hang police signals and take necessary safety measures. The license should specify the transporting items, forbidding overloading and over-speed driving. The transporters in escort should bring the said license for inspection. In not over the limit speed, the speed of the transport vehicles should not lower than 70 km/h and not higher than 90 km/h on highways, and on other ways, the speed should not higher than 60 km/h.

P13 Nearly 730,000 Coalminers in Shanxi Insured Against Work-related Injuries

By May end, this year, 454,000 Shanxi-affiliated state-owned key coalminers had been insured against work-related injuries, hitting 100%; and 274,000 city-and town affiliated ones, hitting 25% of the total. 60% of the coalminers in the province were insured.

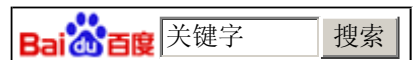
P14 Zhaoyuan Publicizes Safety via Mobile Phone Short Messages

Recently, many mobile phone users in Zhaoyuan city of Shandong Province received the short message which said that because of the impact of Matsa typhoon, the city will face heavy rain, tempest and big tempest accompanied with moderate gale, requesting the residents to take precautions. The city had reportedly used the platform for more than half a year to send short messages about safety knowledge and safety precautions information including road traffic, fire prevention, precautions against electricity, sunstrokes and freezing.

Front Cover: Expertise Consultation on 45 Key Coalmines Safety Status

Coal accounts for 70% of China's primary energy resources. The recent repeated outbreaks of coalmine accidents aroused nationwide vigilance. According to the decision made by the 81st executive meeting of the State Council, the State Administration of Work Safety, the State Development and Reform Commission and two other ministries organized 11 expert groups composed of 91 experts to carry out overall coalmine safety technical consultations over 45 key monitored coalmine enterprises. After three months of arduous work, they came to a shocking conclusion that there were over 3200 hidden dangers in the collective consultation claiming a fund of about 58.7 billion Yuan.
