P12 Premier Wen Jiabao Signs State Council Order No. 446

On September 3 Premier Wen Jiabao signed the State Council Order No. 446 releasing “ the Special Regulation on Preventing Coalmine Production Accidents ” to be effective as of the day of issue. The Regulation specifies 15 categories of coalmines with hidden dangers and behaviors for production stoppage to remove the hidden dangers. It gives five rules on the ways to shut down coalmines: 1. Cancel relevant licenses; 2. Stop supplies and dispose of fire-related tools; 3. Stop supplying electricity and dismantle shaft production facilities, halt power supply and telecommunications lines; 4. Close down and fill up shaft, level well sites and restore geomorphology; 5. Dispatch employees properly.

P12 State Council General Office Notice: Rectify Coal Mines without Work Safety Condition, Close Down Those That Remain Unqualified after Rectification

On August 22, the State Council General Office issued an emergency notice " on rectifying and closing down illegal coalmines without work safety conditions" . According to the notice, the situations of china' s coalmine work safety is still serious, especially the August 7 extraordinary serious flooding of Daxing Coalmine in Xingning city of Meizhou city in Guangdong Province that left 123 dead. The notice urged for immediate action to rectify and close down all illegal coal mines without work safety conditions so as to curb the momentum of accidents.

P13 Li Yizhong Signs Order " Ban Substitution of Money Payment for Labor Protection"

On August 23, Mr.Li Yizhong, director general of State Administration of Work Safety, issued his first order on doing a good job of labor protection equipment supervision and management. The regulation clearly defines that production and management enterprises shall distribute labor protection equipment to all workers and shall not substitute them with money or other articles.

P13 Risk Assessment before Any Large-scale Events

On September 9, " Beijing municipal regulation on safety management of large social events" was adopted by the 12th Beijing Municipal People' s Congress Standing Committee on the 22nd session. The regulation made eight major breakthroughs. Risk assessment and safety inspection, among others, are new measures adopted to suit the trends of development. It brought in stronger penalty and included such measures as to enforce forceful accident scene quitting.

P13 Fujian Province Enforces Traffic Accident Audit and Check System

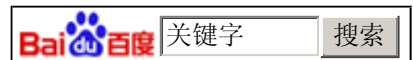
As of September 1, " Fujian Provincial Traffic Accident Audit and Check Regulation" would take effect. The regulation stipulates that the case handling unit shall reformulate the traffic accident certification in case of any improper analysis in the cause of the accident or illegal procedure or improper law application after examination; that the unit shall add evidence and make another certification of the accident in case the facts are partially unclear and the examination group shall cancel the original certification and send it back to the case handling unit for supplementary investigation when the main facts are unclear.

Front Cover: China' s Occupational Health Supervision should be strengthened

It has been two years since China Central Organizational Establishment Office transferred some of the health supervision functions from the health authorities to the work safety authorities in 2003, but no major moves have happened. Why? The correspondent investigates and finds complicated reasons. But what causes greater concerns are the uncertainties regarding such basic issues like who is supposed to take charge, what is to do and how to take charge. The correspondent call that China' s occupational health supervision should be strengthened.
