**The 1<sup>st</sup> Anniversary of the Implementation of Work Safety Law  
An Interview with Wang Xianzheng, Director-General of the State Administration of Work Safety**

Mr. Wang Xianzheng pointed out that the State Administration of Work Safety has formulated within this year such normative documents as *Administrative Punishment Methods for Violations against Law in the Field of Work Safety*, *Administrative Punishment Methods of Coal Mines' Safety Supervision and Opinions Regarding the Implementation of Economic Punishment for Violations against Law in the Field of Work Safety*, etc. This has played an important role in promoting the work safety supervision and control departments at various levels, coal mine safety supervision organizations and their staff to perform their duties according to law.

**P18 Construction Projects Without "Three Simultaneity" Examination may not Proceed with Relevant Administrative Permission Formalities**

The State Development and Reform Commission and State Administration of Work Safety jointly issued a notification recently, demanding that construction projects without "Three Simultaneity" (the safety facilities and main works of construction projects should be designed, implemented and put into production and usage all at the same time) examination may not proceed with relevant administrative permission formalities. The specific supervision and management methods of "Three Simultaneity" of safety facilities of construction projects shall be formulated separately by the State Administration of Work Safety jointly with other departments concerned.

**P24 Legal Norms for Work Safety of High-Risk Enterprises**

The work safety of high-risk enterprises is the key focus of the *Work Safety Law*. The *Work Safety Law* regards high-risk enterprises as the first priority of all the units of production and operation. It has formulated a lot of special and specific legal norms with a view to standardizing the work safety of high-risk enterprises according to law and turning the tables to avoid, as soon as possible, high incidence of grave and extremely serious accidents.

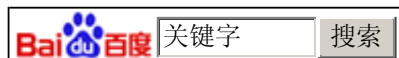
**P46 The First Modern Occupational Safety Cartoons Competition Concluded**
