Guide to Authors

Advances in Climate Change Research invites high-quality research articles, notes, reviews concerned with: interactions of climate change with ecosystems and human societies; long-term changes in climatic elements such as humidity, precipitation, temperature, solar radiation and greenhouse gases; human's response to climate change; government's management and control on climate change; historical case studies; analyses of extreme climate events and climatic hazards; assessment and implementation of adaptation and mitigation options. Applied research includes climate change impacts on agriculture, forestry, fishery and aquaculture; urbanization and economic development; environmental protection and human wellbeing.

Authors should pay attention to the following notes:

1. Papers must be submitted in their final form, bearing in mind that no further correction/addition is possible.
2. Submission of an article is understood to imply that the article is original and unpublished in English in any form and is not being considered for publication elsewhere.
3. Manuscripts should be structured in a way that conforms to that of the journal in question.
4. A recent issue should be checked for information about:
 - a. post address and e-mail of the corresponding author
 - b. keywords, autobiography of the first author, etc.
5. Manuscripts must be written in Chinese or English. Manuscripts written in correct English require less time for review and publication.
6. Authors should use IUGS terminology. The use of S.I. units is also strongly recommended.
7. The manuscript should be prepared on a word processor. The various headings should be clearly differentiated and the first and second order headings should be numbered.
8. The entire manuscript should be paginated.
9. Manuscripts should generally be organized in the following order:

- a. Title is usually required within 100 characters;
- b. Name(s) of the author(s) and their affiliations, tel. & fax numbers and e-mail of the corresponding author. In the case of more than one author, please indicate to whom the correspondence should be addressed;
- c. Abstract should be less than 1000 characters without tables and figures;
- d. Keywords should be 3–8 words;
- e. Introduction;
- f. Area descriptions, methods and material studied;
- g. Results and analyses;
- h. Discussion and conclusions;
- i. Acknowledgments;
- j. References are listed after the text, arranged according to the appearance order in the text. All the listed references should be cited in the text in Arabian numbers with square brackets as superscripts;
- k. Appendices.

The Editorial Office reserves the right of returning to the author for revision-accepted manuscripts and illustrations which are not in the form given in this guide.

The Editorial Office encourages the submission of word-processed manuscripts by post mail and authors can also send manuscripts to us by e-mail. Authors are requested to submit the final text in electronic format and to ensure that the contents of the electronic file correspond exactly to those of the hard copy manuscript.

Advances in Climate Change Research welcomes manuscripts on the above-mentioned subjects. Preference will be given to those from the authors outside China.
