PRESIDENT'S MESSAGE

As a scientific society, WSSA is uniquely positioned to provide real value through our growing impact and leadership on subjects important to the membership and the Nation. This has been a very fast and fun year and WSSA members have been called on frequently to provide science-based information and National leadership in areas critical to the country's success.

I'm especially proud of our S-71 Herbicide Resistant Weed Education Committee and they have made great strides under the leadership of David Shaw (Mississippi State University); this committee has invested considerable time and skill in achieving its goals. In addition to David, the Herbicide Resistant Weed Education Committee includes Sarah Ward (Colorado State University), John Soteris (Monsanto Company, HRAC Chair), Wes Everman (Michigan State University), Jill Schroeder (New Mexico State University), Lee VanWychen (WSSA), Bill Vencill (University of Georgia), Mike Owen (Iowa State University), Greg McDonald (University of Florida), Harold Coble (North Carolina State University) and Jeff Derr (Virginia Polytechnic Institute).

A critical element of the Herbicide Resistant Weed Education Committee's activities is the development of a study, funded by USDA-APHIS, entitled "Herbicide-Resistant Weeds Management Report." This report identifies a number of key methods used to manage the spread and development of resistance in weeds, assesses their effectiveness, the degree of method adoption, the reasons for adoption or non-acceptance, and what can be done to increase the use of integrated resistance management programs. We expect this report to be completed in mid-2011; sooner if possible. The APHIS report writing sub-committee has gotten off to a great start and is making quick progress, this sub-committee includes David Shaw, Ted Webster (USDA-ARS, Tifton, Georgia); Sarah Ward; Bob Nichols (Cotton Incorporated); Kevin Bradley (University of Missouri in Columbia); Jason Norsworthy (University of Arkansas); Nilda Burgos (University of Arkansas); Mike Barrett (University of Kentucky); Bill Witt (University of Kentucky); John Soteris, Stephen Powles (University of Western Australia) and Rick Llewellyn (CSIRO).

As a further goal, an additional S-71 sub-committee has been created to develop a set of herbicide resistance management training modules for the WSSA website and nationwide use. The S-71 subcommittee is also making excellent progress on their task, lead by John Soteres, this sub-committee includes, Wes Everman, Les Glasgow (Syngenta Crop Protection), Jill Schroeder, David Shaw, Jeff Stachler (North Dakota State University), and Francois Tardif (University of Guelph).

These Herbicide Resistant Weed Education Committee efforts represent a substantial investment of member time and energy and we all very much appreciate the contributions being made. Plans are being considered to have a national symposium as a roll-out for the APHIS report, as well as a demonstration of the materials developed for the WSSA website. The National Research Council (NRC) has invited WSSA to hold the symposium at the National Academy of Science in Washington, DC in 2011.

David Shaw, Jill Schroeder and a number of the members of the Herbicide Resistance Education Committee attended the National Association of Conservation Districts (NACD) Herbicide Resistant Weed Task Force meeting in Little Rock, Arkansas on August 9 through 11, 2010. The meeting attendees included NACD members, Natural Resources Conservation Service (NRCS) staff, North America Herbicide Resistance Action Committee (NA HRAC) members, and university weed scientists. The agenda included a group discussion of best management practices for herbicide resistant weeds, the product of the meeting was a NACD white paper discussing the impact of herbicide resistant weeds on conservation programs and best management practices to manage their occurrence and spread. A paper describing these BMP's was drafted for NACD's use by Jill Schroeder and John Soteres and was reviewed by members of Global HRAC, the WSSA S-71 Committee and other university weed scientists attending the NACD symposium before being provided to NACD for inclusion in their white paper.

In close cooperation with EPA, our EPA Subject Matter Expert, Jill Schroeder, continues to lead an educational effort to assist the EPA Office of Water, Registration Division, and Biological and Economic Analysis Division in understanding weed management's needs in the riparian corridor. This is especially timely, as the States will need to implement National Pollution Discharge Elimination System (NPDES) permits by April 2011. In May 2009, Jill participated in a fact-finding field tour for EPA Office of Pesticide Programs and Office of Water staff to learn about aquatic pest management issues in Florida; this tour was organized and hosted by Drs. Bill Haller (University of Florida) and Kurt Getsinger (US Army Engineer Research and Development Center). Since the management issues related to weed and invasive plant management in riparian areas are very different in the Western US, a second tour was organized this year to provide information about a Western ecosystem that dramatically contrasts with Florida; Jill Schroeder and Bonnie Rabe (New Mexico Department of Agriculture Division Director Ag and Environmental Services) organized and hosted this August 2nd through 5th, 2010 tour for EPA staff to New Mexico to learn more about water and weed management in the riparian areas of a land-locked, arid state. This was a particularly important educational opportunity for the Agency, as the comment period for the draft NPDES General Permit has recently closed and EPA staff are beginning to finalize that document. It is critical for EPA to learn first-hand about the weed management operations made for maintenance and invasive species management and there is no substitution for an on-the-ground education. We greatly appreciate the assistance and arrangements made by David Lucero (New Mexico Division Director Marketing and Development) and Kirk McDaniel (New Mexico State University Range Science) for this visit.

The regulation of spray drift is also important to the National interest and WSSA is committed to advancing the state of knowledge in application technology. To help EPA understand the technological advances that have occurred since the Spray Drift Task Force developed the current data used for regulatory assessments, our WSSA Subject Matter Expert hosted a September 14th seminar at EPA on the evolution of sprayer technology by Dr. Bob Wolf (Kansas State University); this seminar was also presented earlier that day to the American Farm Bureau Foundation. In these discussions, Bob presented information about the latest equipment and nozzle technologies used to apply crop protection products to achieve optimum control of undesired pests while minimizing drift. As future guidelines regarding spray drift minimization are established, more technologies will be developed and validated; these developments will require sound research to support adoption and the future and science of application technology is very exciting. This seminar was very well attended by staff from all EPA divisions. Drs. David Shaw and Lee Van Wychen also attended as representatives of WSSA.

Planning is advancing well for a March 14th through 16th, 2011, Invasive Species Advocacy Week through the careful efforts of the Healthy Habitats Coalition as coordinated by Tracee Bentley (HHC Executive Director, Peak Resources, Colorado). The goal of this event is to expand the understanding and awareness of invasive species management/restoration needs and enhance the resource and infrastructure that supports increased invasive species appropriations that improve the government's capacity to prevent and control this difficult problem.

We are also working on a separate National Invasive Species Awareness Week event on February 28th through March 4th, 2011, coordinated by Lori

Williams, Executive Director, National Invasive Species Council and Lee Van Wychen. Planned events include a week of activities, briefings, and events to highlight what is being done across the nation and around the world to stop and slow the spread of invasive species, including a State Invasive Species Council and Regional Coordination Workshop, National Press Club Announcement of the National Invasive Species Agenda, briefings on regional invasive species issues (Great Lakes, Southeast, West, Northeast) and receptions and educational programs at the United States Botanical Garden and National Aquarium.

I wanted to also take a moment to talk about the WSSA Board of Director's summer meeting. We had the opportunity to preview the Hilton Portland & Executive Tower Hotel and it's a fantastic location for the 2011 National Meeting! We took an extra day for strategic planning and have a number of ideas that we'd like to cultivate, including funding a new "Losses due to weeds" monograph, the creation of K through 12 Weed Science based teaching materials, on-line versions of the Herbicide Handbook, exploring graduate student internships at EPA, working through our graduate student organization to invite local undergraduates to our national meetings, as well as seeking future joint meeting with the Regional Societies.

It's my real great pleasure to see the 2011 WSSA National Meeting taking shape for February 7 to 10, 2011 in Portland, Oregon at the Hilton Portland & Executive Tower Hotel. This will be the first traditional WSSA meeting we've had in a while and our Program Chair, Mike Barrett, and Program Vice-Chair, Rod Lym, have strived to make this a gathering where Weed Scientists from around the world will have the opportunity to present and share their latest research results, expand their awareness of crit-

ical emerging issues, network to identify new solutions in weed management and enjoy the fellowship of our Society. Our Local Arrangements Committee, led by Carol Mallory-Smith and Tim Miller, has done a wonderful job in selecting an excellent site to create an opportunity that is certain to be both rewarding and memorable. I also want to thank Mark Czarnota (University of Georgia) for making the arrangements for a Sunday Plant Nurseries and Wine Tasting tour. The scientific program will feature six special-topic symposia as well as poster and oral paper presentations on the latest weed science research. Also, this year, we're trying something completely new and have convened a "Practitioners Forum" to address perceptions and misconceptions about weed management and research; this session is intended to start a conversation between On-the-Ground Weed Managers with University Extension and Research Faculty and Industry. The forum's goal is to find better ways to communicate research findings to Weed Managers and for Weed Managers to communicate their information needs more effectively to researchers. WSSA strives to better serve the Weed Practitioner community and invite their participation in the Society and through forums like this; through this discussion, Weed Scientists can gain additional insight into the challenges practitioners face.

The entire 2011 WSSA National Meeting program will be posted on the WSSA web site (www.wssa.net) where attendees will have the option of preparing their personal schedule for the meeting in advance. Printed programs will be mailed to those U.S. attendees pre-registered before January 7, 2011; please be sure to bring those programs with you to the meeting, as programs will only be provided to international attendees and on-site registrants at the meeting registration desk. ASSISTANT RESEARCH PROFESSOR, AGRONOMY DELTA RESEARCH & EXTENSION CENTER

This is a 100% research position with Mississippi State University and the Mississippi Agricultural and Forestry Experiment Station located at the Delta Research and Extension Center (DREC) in Stoneville, MS. The incumbent will develop a nationally recognized scholarly research program supported by external funding sources that addresses critical agronomic issues in a diversity of crops (corn, cotton, soybean, peanuts and wheat) grown by producers in the Mississippi Delta and surrounding areas.

Essential Duties and Responsibilities: Conduct in-depth research in major row crops commonly grown in Mississippi to optimize inputs for profitable production. Work with commodity groups, growers, and agribusinesses to promote Mississippi row crops and identify techniques to overcome production problems that limit yields and/or profitability. Cooperate in research projects with other

agronomists, entomologists, plant pathologists, and weed scientists at DREC, Mississippi State University, and USDA-ARS. Collaborate with MSU Extension agents and specialists to plan and conduct on-farm research and demonstrations. The incumbent will have the opportunity to coordinate, evaluate, summarize, and publish the Mississippi Cotton On-Farm Variety Trial (OVT). A demonstrated ability to effectively communicate research findings and troubleshoot problems with growers, consultants, and extension personnel is desired. Incumbent will also be expected to secure extramural funding to support research activities, publish research findings in appropriate professional research journals, and make presentations at professional meetings. Incumbent will be encouraged to participate in graduate student training and contribute to collaborative teaching in offcampus and campus-based educational programs in agronomy.

Minimum Qualifications: Earned doctorate in Agronomy or related field.

Preferred Qualifications: Strong background in row-crop agronomics as well as demonstrate ability to publish research findings in peer-reviewed journals and develop grant proposals and secure extramural funding.
